As an applicant for a revocable license to use the Brother Robert Athletic Facility located at 8777 Common Road, Warren, Michigan and all equipment located therein (collectively, the "Facility") owned by DeLaSalle Collegiate High School ("Owner"), I, the individual named above (also referred to herein as "myself") understand that I am applying for a revocable license for myself and of my child (as defined below) to use the Facility and related equipment as such Facility and equipment is provided by the Owner from time to time and, if granted such license to use the Facility and equipment, I, for myself and/or my child shall at all times abide by the Facility's rules and/or regulations, as the same may be established from time to time by Owner. I further agree to comply with all instructions from Owner's representatives regarding the use of the Facility and/or the equipment. I agree that I will pay any and all fees charged by Owner, as such fees may be established from time to time, in the manner directed by Owner.

On behalf of myself and/or as legal guardian of each of the children named above (herein, whether one or more, collectively referred to as "my child"), I hereby consent to my child's use of the Facility or participation in programs and/or any other related (directly or indirectly) activities held at the Facility, whether conducted by Owner or any other occupant of the Facility. I understand that all children, including my child, age 12 and under must be accompanied by a parent, responsible adult or coach while using the Facility.

I fully understand the potential risks of injury to myself and/or my child common to using the Facility and participating in the activities sponsored by Owner or another occupant of the Facility and/or related activities and fully assume the risks associated with such participation. I recognize that accidents occur and that all risks cannot be eliminated or controlled. I also recognize that some risks cannot be anticipated. I further understand that Owner is not responsible for personal property lost, damaged or stolen while using the Facility, including parking lots, or participating in programs at the Facility.

In consideration of being granted a license to use the Facility and its equipment, I hereby release, waive, absolve, covenant not to sue, and agree to indemnify, defend and hold harmless, and on behalf of my child I hereby release, waive, absolve, covenant not to sue, and agree to indemnify, defend and hold harmless, Owner and it's officers, trustees, directors, employees, agents, patrons and volunteers from and against any and all claims, demands, actions of whatsoever kind or nature, causes of action, damages, costs, liabilities, expenses or judgments, including, but not limited to, attorneys' fees and court costs, and any other liability for any and all injury, loss, damage, misadventure and/or inconvenience occurring to myself and/or my child or arising out of my and/or my child's participation in the Owner's activities or programs at the Facility. I assume all medical obligations for myself and/or my child in the event of accident or injury while participating in activities at the Facility. I acknowledge and understand that the

Owner does not provide accident or health insurance for users of the Facility. I further agree not to sue or make any claim of any nature whatsoever relating to or arising out of my participation in programs or use of the Facility or its equipment in any court, agency or other forum against any individual or entity whom I have released and agreed to hold harmless in this paragraph.

I understand and agree that this Participant's Application and Waiver is valid in all respects, now and in the future, and may be kept on file by Owner. This Participant's Application and Waiver, having been read thoroughly and understood completely, is signed voluntarily as to its content and intent.

I acknowledge and agree that my use of the Facility (and/or my child's use of the Facility) is permitted at the sole discretion of the Owner and that either myself or my child can be excluded from the Facility at any time for good reason or no reason at all. I acknowledge and agree that any person deemed a threat to the security or personal safety of any other user of the Facility is subject to immediate removal from the Facility and revocation of the license granted by Owner. Owner may cease to offer the use of the Facility and the related equipment (or parts thereof) to applicants including myself and/or my child at any time or from time to time, provided that Owner shall refund any prepaid fees paid by the undersigned.
